Application for bringing mobile phones to school

The college has always aimed at improving students' academic performance and other areas of development. We expect students to focus on studies in class and actively participate in various academic and extra-curricular activities. We used to allow students to bring mobile phones to school for parents to contact them and for use after school. However, with the advancement in technology, students may easily become addicted to the phone for different purposes other than communication. Parents have to be alert to the possible abuse of phones and negligence in studies. As such, we urge you to consider thoroughly whether there is a genuine need for your child to bring a mobile phone to school. In any case, it is advisable to bring modest models.

In this school year, we will enforce stricter measures in their use. Please refer to the school rules as well as the regulations stipulated below. We look forward to your full cooperation in the implementation of these new measures.

Besides mobile phones, students are not allowed to bring other electronic devices such as iPads and laptops to school. The school has a sufficient number of computers for students to use in class. Prior application for permission to bring such items to school is necessary.

Meanwhile, we would like to bring your attention to the importance of not allowing your child to bring expensive models of phones to school. Students should bear the responsibilities to look after their properties, especially when they leave their homeroom for elective classes or PE/IA lessons. Students are asked to keep an eye on their valuables or put them in the locker fastened with their own padlock.

If you insist there is a genuine need for your child to bring his/her mobile phone to school, please complete the reply slip and ensure that he/she will adhere to the regulations regarding its use. Applications have to reach the mentor by September 9 and they will be considered on a case-by-case basis. Late submissions will not be entertained.

Regulations for bringing mobile phone to school

- 1. To maintain a disturbance-free learning environment, using mobile phone is strictly prohibited inside the school campus.
- 2. Mobile phones must be switched off before entering the school and could only be used outside school.
- 3. Parents should not make phone calls or send messages to their children during school hours. For emergency, please call the School General Office at 2390 5010.
- 4. On non-school days (e.g. supplementary lessons or activities during holidays), students must follow the instructions of the teacher-in-charge concerning the use of mobile phones.
- 5. Students should not lend their mobile phones to their schoolmates. Once the mobile phone is found misused, both the owner and the borrower will be punished under the same rules. The borrower will also have to go to detention classes or execute school campus services, on top of the deduction of 3 conduct marks.
- 6. Students who bring and use mobile phones without application will also be punished attending detention classes or executing the school campus services, on top of the deduction of 3 conduct marks.
